The eligibility criteria are listed below. Only candidates whom the panel certify as meeting the eligibility criteria may stand for election or be appointed Trustee.

NOMINEE SKILLS WILL BE ASSESSED AGAINST THE FOLLOWING:

- an understanding of Waitaha tikanga, reo and cultural values
- an understanding of the Waitaha Treaty Settlement
- undergone formal governance training or have the requisite experience in this area
- ability to think strategically including the ability to understand and direct strategy;
- common sense, integrity a strong sense of ethics, and sound judgement
- general computer literacy; and
- financial literacy

CANDIDATES MEETING

1. All nominees certified by the independent panel, as meeting the eligibility criteria are expected to attend a Candidate Meeting at Hei Marae Wednesday 25th October commencing 6.30pm – 8.00pm.
2. At the Candidates Meeting, each candidate will be given an equal opportunity to present to the meeting and will be expected to remain to answer any questions from the iwi.
3. In the event that the total number of nominations certified as meeting the eligibility criteria is equal to the total number of vacancies, no Candidates Meeting or election shall be necessary and the person or persons nominated shall be deemed to have been duly appointed.
